The party/parties agree to specifically assume all risks of injury arising out of the use of the Y, participation in activities and use of all equipment and spaces within the entire facility.

Entirety of Agreement:

This document represents the entirety of the agreement between the Y and the party/parties. Any changes or modifications to this agreement shall be completed in writing and signed by both parties. Either party may cancel the contract by giving the other party thirty days' written notice. The Y has the right to cancel this agreement without notice if fees are not paid according to the payment schedule.
